- 1. Party Covered by this Warranty:** This warranty is expressed for the sole benefit of the original consumer/purchaser and is not transferable.
- 2. Duration of the Warranty:** This warranty becomes effective when exercise machines are delivered.
 - 2.1 Ten Years:** Structural frame to be free from defects in materials and workmanship.
 - 2.2 Five Years:** Bearings, bushings, sprockets, chains, drive belt, shafts, cams, springs, and weight stacks.
 - 2.3 Ninety days:** Upholstery, seat belts, hand grips, shields, decals and all parts not otherwise listed.
- 3. Extent of Warranty Coverage:** This warranty applies exclusively to MedX exercise machines. MedX is not liable for damage or defects due, in its judgment, to abuse, lack of proper maintenance, accident, movement or adjustment of equipment by personnel not authorized by MedX, modifications of components, parts, other products not manufactured by MedX. Further, any of the foregoing acts or events shall void this warranty as to the entire affected equipment and MedX shall have no further responsibility with regard thereto.
